Council President Ralph Duckwall called the meeting to order and Councilman Wiles led the group in prayer and the Pledge of Allegiance.

COUNCIL ACTION

HEALTH DEPARTMENT

The Health Department Board came before the Council to request that the part time Health Environmentalist become full time. President Duckwall expressed concern that enough money had not been advertised and the additional cost that County General would incur. Mrs. Collie, Health Board assured the Council that enough money was asked for and that they had enough money to cover all expenses. It was also expressed that Mr. Mofield would not be taking the County insurance.

Commissioner Jon Faust asked for everyone to speak up as it was hard to hear in the back of the room. Commissioner Faust expressed concern because the Commissioners budget has been cut a lot and asked the Council to consider what the cost would be to the County General specifically the Commissioners as all benefits are budgeted in the Commissioners budget.

Councilman Jan Kendall made a motion to make the part time Health Environmentalist Assistant full time. Councilwoman Mull 2nd the motion and it passed 6-0.

Council President Ralph Duckwall asked if there were any additions to the agenda. Councilman Steve McAuliffe stated that the Council will address the non-binding reviews after item 10 on the agenda before adjourning.

COUNCIL DISCUSSION

Councilman Wiles asked about the new training fund. President Duckwall explained that the Recorder collects fees, part of which goes into the Elected Officials Training Fund. The Auditor explained that before July 1, 2012 it was only for the Recorder, Clerk and Surveyor. After July 1, 2012 it included the Auditor, Assessor and Treasurer. Those Elected Officials will be required to have more training hours and that money is to help with the cost.
