

MIAMI COUNTY ORDINANCE NO. 1-3-2000

ORDINANCE OF THE BOARD OF COMMISSIONERS
OF MIAMI COUNTY ESTABLISHING A COPYING FEE

WHEREAS, I.C. 5-14-3-8 entitled "Fees; Copies" grants local government units the authority to establish fees regarding utilization and copying of public records; and

WHEREAS, I.C. 5-14-3-8(d) requires any public agency that is not a State agency establish a fee schedule for the certification, copying or facsimile machine transmission of documents; and

WHEREAS, this established fee may not exceed the actual cost of certifying, copying or facsimile transmission of the document by the government agency and said fee must be uniform throughout the public agency; and

WHEREAS, I.C. 5-14-3-8 defines actual cost as the cost of paper and the per page cost for the use of copying or facsimile equipment and does not include labor costs or overhead costs; and

WHEREAS, upon receipt of information has been determined to be of necessity that Miami County public agencies establish a fee for copying and/or facsimile transmission.

NOW, THEREFORE BE IT ORDAINED AND ORDERED by the Board of Commissioners of Miami County as follows:

SECTION I

Pursuant to I.C. 5-14-3-8 the Board of Commissioners of Miami County hereby elects to establish a copying and/or facsimile fee schedule. The Copy Fee Schedule shall be as follows:




